**INSTRUCTIONS TO VOTERS:**

To vote, complete the oval to the LEFT of your choice, like this ( ● ). To cast a write-in vote, complete the oval to the LEFT of the blank space provided and write the candidate's name in that space.

An OVERVOTE will occur if you darken the ovals for more candidates than instructed. The ballot counter will alert you if you cast an overvote. An UNDERVOTE occurs when you vote for fewer candidates than instructed. In both instances, it will not affect the offices that were voted correctly on the rest of the ballot.

For specific information, refer to the card of instruction posted in the voting booth. If you tear, soil, deface or erroneously mark this ballot, return it to the Election Judge and obtain another. Vote both sides of ballot if applicable.
